**Eligibility Criteria:**

- i. The applicant shall be a distinguished academic with a PhD or equivalent having at least fifteen years teaching or research experience and shall have worked as a full Professor at a reputed institution for at least seven years; or shall have industry experience of at least 15 years and at a higher level for at least seven years.
- ii. Age of the applicant shall not be more than sixty years as on 1<sup>st</sup> January 2021.
- iii. Experience shall be reckoned as on the last date for receipt of applications.
- iv. The applicant shall be an Indian Citizen or an Overseas Citizen of India (OCI).

**Desired Criteria:**

The ideal candidate would possess the following:

- i. Outstanding academic credentials from an educational institution or business school of repute.
- ii. A good track record of accomplishments in academic, including research papers in reputed journals.
- iii. Good record of administrative leadership positions.
- iv. Attributes, skills and knowledge for institution-building including strong industry-connect.
- v. Candidates from an industry to have reasonable exposure to teaching as adjunct faculty.

Process of Selection:

The Search-Cum-Selection Committee (SCSC) constituted by the Board will consider applications received in response to this advertisement as well as the candidature of those received on nomination or search basis, fulfilling the above criteria. The applications and nominations shortlisted will be limited to a reasonable number based on essential and desired criteria. The SCSC will then have an interaction with the shortlisted candidates. Appointment shall be in accordance with the IIM Act 2017 and IIM Rules 2018.
