## Message

**Digital India** is a flagship programme of the Government of India (GOI) catalysing the transformation of the country as a digitally-empowered society and knowledge-economy. These are going to play a crucial role in the government and industry alike, whether it is planning or decision-making; accelerating development or analysing deployment, problem solving or product development; discovering new trends or drawing out unknown correlations.

The Ministry of Electronics & Information Technology (MeitY) is engaged in development and strengthening of digital capacities at all levels. The National e-Governance Division (NeGD) has been playing a pivotal role in supporting MeitY in the implementation of the Digital India Programme and in building required capacities at various levels. In furtherance of this endeavour, NeGD partnered with the Indian Institute of Management Visakhapatnam (IIMV), an institution of national importance, in launching a bespoke MBA program specializing in Digital Governance and Management. The first batch of the Programme was launched successfully and the participants have shared highly positive reviews about the programme's relevance and its innovative pedagogy. The stage is now set for the commencement of the second batch.
