1. SCOPE OF WORK:

Providing Group Health Insurance Policy (GHI) & Group Personal Accident Policy (GPA) for IIM Visakhapatnam PGP and PhD Students for year 2023-24, as per Scope of Coverage given in PART-I

2. ELIGIBILITY CRITERIA

- a. Bidder should be an Insurance Agency registered with IRDA for providing Health Insurance. Insurance Broking Companies are **not eligible** to participate in this tender.
- b. Bidder should have at least 5 years of experience in providing the health Insurance related services.
- c. Bidder should have a registered or branch office in Visakhapatnam, Andhra Pradesh.

- d. Bidder should have an inhouse or Third Party Administrators (TPA) for settlement of claims, available on 24x7 basis.
- e. Bidder should have an agreement with at least 4 major hospitals located in Visakhapatnam for cashless treatment, currently.
- f. The bidder should have registered for GST & Income Tax.
- g. The bidder should not have been not involved in any major litigation or blacklisted by any of the Central/State Government or any other Govt. organization or a corporate body.
- h. Bidder should produce a dummy copy of their GMC & GPA policy

Bidders should submit the documentary proofs for meeting above criteria as mentioned in the Technical Bid document.

3. INSTRUCTIONS TO BIDDERS:

A. Tender Fee and EMD:

Tender Fee is NIL. All the bidders should submit a 'Bid Securing Declaration form' as per Annexure-II in lieu of EMD. Bidders, if withdraw or modify their Bids during the period of validity, or if they are awarded the contract and they fail to sign the contract, or to submit a performance security before the deadline defined, they will be suspended for the period of 02 years from being eligible to participate in the tender process for notices issued by the Institute. Bidders registered with MSMS/NSIC are to submit valid registration certificate along with tender documents.

- <u>B.</u> <u>Bid Validity:</u> The bids shall be valid up to 90 days from the closing date of the bid submission. Withdrawal of bids is not permitted after the closing date.
- <u>C.</u> <u>Submission of Bids:</u> Bids should be submitted in two-part single stage system i.e., Technical and Financial Bids at a time.
 - i. The Technical bids should contain following documents in same order:
 - a. Letter of submission of bid Annexure I
 - b. EMD/Bid Security Declaration Form Annexure-II.
 - c. Technical Bid as per Annexure-III with all required documents as mentioned thereon
 - d. Declaration of non-black listing Annexure- IV
 - e. Tender document signed on all pages

All these documents should be signed by the authorised signatory of the bidder and stamped. They should be arranged in same order, serially numbered and stapled/bound and placed in one envelop cover and labelled as '**Technical Bid for Tender for GHI& GPA for Students 2023'** and sealed properly.

- <u>ii.</u> The Financial Bid, should be submitted in format in Annexure-VII, should be placed in a separate envelope and labelled as 'Financial Bid for Tender GHI & GPA for Students 2023' and sealed properly.
- iii. Both these covers (Technical Bid and Financial Bid) shall be placed in outer envelope and sealed properly. This outer cover shall be labelled as "Bid for Tender for GHI & GPA for Students 2023', addressed to the authority mentioned in the Notice Inviting tender and delivered at IIMV office by Hand/post/courier etc on or before the last date for closing of the bids mentioned thereon.

- iv. Bids received after the last date and time mentioned in the notice will be rejected. IIM Visakhapatnam is not responsible for delay in submission of bids.
- D. Rejection of Bids: Bids submitted in any other format; Bids without the required documents as mentioned in the tender document; Bids with forged/tampered/fake documents; Bids submitted or received after the last date and time mentioned in the notice; Bids without EMD as mentioned in the notice; Bids with validity less than 90 days; Bids with any conditions by the bidder; Bids with financial values mentioned in technical bids; Bids with documents in open covers; Bids not signed by the authorised signatory; Partially quoted bids; or bids with any other conditions suitable for rejection are liable for rejection.
- E. <u>Amendments to the Tender Document</u>: For any changes in the terms and conditions of the Tender document, a Corrigendum shall be issued and uploaded in the website only. No separate communication will be sent to any bidder/agency in this regard. Bidders are advised to visit the Institute's website for any updated under 'Tenders' section.
- <u>F.</u> <u>Opening of Bids:</u> The Technical bids will be opened on the date and time mentioned in the notice in presence of representatives of the Bidders. Bidders or their representatives willing to attend the Technical Bid opening should produce the authorisation letter as per Annexure-V. Only, one person for the bidder will be allowed to attend the bid opening.
- <u>G.</u> <u>Evaluation of Bids:</u> The Technical bids will be evaluated for determining 'Eligibility Criteria' and the Financial Bids of eligible bidders only will be opened. The bidder with most competitive price as per the Financial Bid will be declared as successful bidder.
- <u>H.</u> The Institute reserves right to seek any clarifications, documents, if required, during the process of evaluation. In case the bidders fail to submit the information required within the time limit mentioned in the communication sent to them, the bids will be evaluated based on the documents and information available accordingly.
- <u>I.</u> The bidders, who do not meet the eligibility criteria; or do not submit all the necessary documents in support of the eligibility criteria; or do not submit documents that are complete and valid shall be disqualified.
- <u>J.</u> Indian Institute of Management Visakhapatnam reserves the right to accept or reject any or all the tenders or cancel this process at any time without assigning any reason whatsoever.
- K. Bidder signing the tender form or any other documents forming part of the contract on behalf of the Bidder shall be deemed to warranty that he has authority to bind the Bidder. If subsequently comes to light that the person so signed had no authority to do so, IIMV may without prejudice to any other civil & criminal remedies cancel the tender and hold the Bidder liable for all costs, charges, and damages.

4. COMPLIANCE WITH THE INSTITUTE RULES AND REGULATIONS:

The Agency shall comply with all norms stipulated by the Institute regarding maintenance of discipline, decorum, etiquette, safety, security, and hygiene at and around the

workplace. Strict compliance with all guidelines/procedures etc. issued by the MHA/MoE/MoHFW/Local Authorities/Institute in relation to the COVID-19 pandemic or any other such contingencies/exigencies shall be duly observed while entering and during the stay at the office, while interacting with the staff & students.

5. PAYMENT TERMS:

Premium for the policy will be paid on submission of Proforma Invoice complete with the details of the group and coverage. Tender/Purchase order No. to be mentioned in the invoice for reference. Payment only by e-payment mode.

6. FORCE MAJEURE:

If at any time, during the continuance of the agreement/contract, the performance in whole or in part, by the firm, of any obligation specified in the agreement/contract, is prevented, restricted, delayed or interfered, by reason of war or hostility, act of the public enemy, civil commotion, sabotage, act of State or direction from statutory authority, explosion, epidemic, quarantine restriction, fire, floods, natural calamities or any act of GOD, (hereinafter referred to as event), the firm/agency may be excused from performance of its obligation provided that notice of happenings of any such event is given by the firm to IIMV within two calendar days from the date of occurrence thereof. Provided further that the obligations under the Agreement shall be resumed by the firm, as soon as practicable, after such event comes to an end or ceases to exist. The decision of IIMV as to whether the obligations may be so resumed (and the time frame within which the obligations may be resumed) or not, shall be final and conclusive. However, the Force Majeure events mentioned above will not in any way cause extension of the period of the Contract.

12. ARBITRATION:

In the event of any dispute arising between IIMV and the agency in any matter covered under this Agreement/Contract or arising directly or indirectly therefrom or connected or concerned with the said Agreement/Contract in any manner of its implementation of any terms and conditions of the said Agreement/Contract, the matter shall be referred to the Director, IIMV who may act as sole arbitrator or may nominate an officer of IIMV as sole arbitrator, notwithstanding the fact that such officer has been directly or indirectly associated with the contract. The firm will not be entitled to raise any objection for the appointment of such officer of IIMV as the sole arbitrator. The award of the arbitrator shall be final and binding on both the parties to the agreement subject to provisions of Arbitration and Conciliation Act, 1996 and rules made thereunder. The parties expressly agree that the arbitration proceedings shall be held at Visakhapatnam, Andhra Pradesh. The language of arbitration shall be in English only.

Any clarification regarding the meaning or intent or interpretation of any of the provisions of these terms and conditions required at any point shall be sought from Director, IIMV whose decision in the matter shall be final and binding. Any other matter relevant to but not covered in the Contract shall also be decided by making reference to him and his decision shall be final and binding.

13. JURISDICTION OF COURTS:

All disputes arising, if any, under this tender/contract shall be subjected to the jurisdiction of courts in Visakhapatnam, Andhra Pradesh only.
